## Overall Activity Objectives:

- 1 Manage breast and other gynecologic cancer-related conditions in obstetric patients following evidence-based guidelines
- 2 Implement up-to-date management strategies for those cancers
- 3 Identify indications for referral to REI (Reproductive Endocrine and Infertility) specialists in patients with gynecologic cancers who desire future fertility
- 4 Diagnose and treat thyroid conditions in women following evidence-based guidelines
- 5 Implement interdisciplinary care for endocrine, neurological, and cardiac conditions in the obstetric and gynecologic patient populations.
- 6 Appraise and examine quality metrics within women and infant services by reviewing complex and unique cases.

## Session Objectives:

- 1 Identify the clinical and pathophysiological causes of disseminated intravascular coagulation (DIC) in obstetric patients.
- 2 Construct and apply a simplified, bedside-appropriate model of the clotting cascade to inform urgent clinical decision-making.
- 3 Analyze and implement evidence-based therapeutic interventions for managing DIC during pregnancy.
